2019 has certainly been a year of tremendous growth at ACT for Meningitis in terms of reaching communities across Ireland with Awareness and Support. This year alone we have managed the distribution of 50,000 patient information leaflets to 1,250 healthcare facilities and facilitated 30 awareness talks, with the distribution of 65,000 life saving awareness card nationally. The impact of these campaigns is the teaching of meningitis awareness, how to spot the signs & symptoms and what to do in this instance, to over 120k people in Ireland. This is groundbreaking work for a small charity and we the board of directors are continuously proud of the

impact this work is making to the outcome of this disease.



### **About ACT for Meningitis**

ACT for Meningitis was set up in 2011 by Siobhan and Noel Carroll following the tragic loss of their daughter Aoibhe, aged just 4, to Meningitis. Losing Aoibhe changed their lives forever and they wanted to try and prevent another family going through that heart break. They felt there was an urgent need for more awareness around Meningitis and that support be made available to anyone affected by the disease, therefore, in July 2011 they set up ACT for Meningitis, with a Mission to raise awareness, to promote education and to provide support to those affected by meningitis in Ireland, and with a vision to see an Ireland where lives are no longer lost to meningitis, and through our support services no-one faces the meningitis journey alone.

ACT for Meningitis

A non-government funded small organisation of just four part-time staff ACT are completely focused on trying

to make a big difference. In just 8 short years through self-fundraising ACT have become the only organisation to offer a vast range of free support services to anyone in Ireland affected by Meningitis, either through bereavement of living with the severe after affects of this lifechanging disease.



### **Support Services**

Our support services are tailored to the needs of the individual /family to find the most appropriate and beneficial service for them. Meningitis has a wide range of severe side affects coupled with the trauma of the experience and in 1 in 10 cases it tragically results in bereavement. Our trained family support officer assesses where the charity will be most beneficial in providing support.

Our services include creative therapies-including play and art therapy which help children deal with the impact of the disease, free



counselling services for families or individuals who have been affected by Meningitis, Cranial Sacral Therapy, physiotherapy ,psychologist assessment, one to one support, and family support days.



Our various annual national awareness campaigns such as our Student Awareness Campaign, the Winter Warning, our Back-to-School Campaign and ACTion Teds Crèche Campaign enable us to reach thousands of new people every year with awareness. We further continue our awareness raising activities through print, radio and social media campaigns further reaching millions with life saving awareness.

### **Awareness & Education**

ACT for Meningitis is committed to raising awareness of the signs and symptoms of Meningitis. To date, we have distributed over 235,000 awareness cards and have held numerous talks and presentations to schools, community groups and the public across the country further supplying numerous facilities, such as universities, crèches, schools, pharmacies and many places of work, with these life-saving cards..





Knowing the signs and symptoms of Meningitis can save a life. ACT for Meningitis will strive to ensure through our awareness and education we can reduce the impact of this disease.



# **Awareness 2019**

2019 has once again been a great year for ACT in terms of raising awareness. We are continually moving with the times but also continuing with the awareness avenues that have been consistently successful in raising meningitis awareness all over the country.



Our student awareness continues in colleges nationally since its launch in 2015, this year we pushed the #mindyourfriends campaign and invested in new stand awareness materials to keep up to date. We also asked our work experience volunteers to help design a TY campaign and all secondary schools were contacted with our awareness information and continue to visit schools to provide awareness talks when requested.

We attended Zeminar in September,a national youth event about well being and education to spread our #mindyourfriends campaign.

We continue to raise awareness through fundraising campaigns like the rainbow party which includes an awareness card for all participating children's homes which is 'direct to parents' awareness. We also made new links in Killarney and Cork via fundraisers where Siobhan gave awareness talks. These are new communities and links for the charity to reach even more people with our life saving information.



We were also delighted to have our logos printed on the team jerseys for Elphin GAA club and also welcomed Donegal footballer, Eoin McHugh as a new ambassador to help up raise meningitis to GAA supporters nationwide

World meningitis day in April was focused on #LifeAfterMeningitis and boasted post reach of over 100,000 on the day with our messages after meningitis. Siobhan spoke on RTE1 with Miriam O 'Callaghan and an article featured in the Irish times. We also linked in with GBBS for group B strep awareness month in July and continue to share their information via our social media and at health promotion events.

Our biggest achievements of 2019 have been our continued relationship with the National Ambulance Service and the Irelands Practice Nurses Association, we hosted talks in Ballinasloe and Mayo which lead to a further invite to the IPNA national conference on 29th September where we proudly launched our new awareness card holders and handed them out to hundreds of nurses at the conference, they were snapped up and had really positive feedback.





# Awareness 2019 continued...

We this year developed new countertop awareness card holders to be distributed to pharmacies nationwide. These are being sent out in phases to 500 pharmacies at a time and will continue with this as well as a refill programme scheduled for next year.



Our new digital poster was launched and Inform continue to stock our awareness leaflets in thousands of GP surgeries and health centres across Ireland with the last delivery of the year going out December 18<sup>th</sup>.



We continue to learn and to help educate people with our life saving awareness and continue to look forward to the New Year.



# Fundraising in 2019

As always, in the absence of ongoing government funding, the focus for income during 2019 has very much been on Community & Corporate Fundraising, which thankfully remains strongly supported in many communities across the country. Corporate donations from several of our partnered companies in Ireland and volunteer led fundraising events in aid of ACT, funded the majority of our annual National Awareness Programmes throughout 2019. The further expansion of our Community Care Programme to 24 Counties this year resulted in increased costs, which were met by the surplus income from our own annual fundraising events throughout 2018.





### **Grants & Trusts**

The successful application to six CHOs of the HSE for National Lottery funding resulted in a grant allocation of €6,133, equating to 4% of our overall income. This grant directly funded a series of National Group Support Workshops, which oversaw the training of parents with families affected by meningitis, to overcome its side effects. These workshops took place from September to December 2019.

Grants awarded by two foundations this year, The Hospital Saturday Fund (€4,000) and he JP McManus Fund (€2,000) funded a "Reconnecting After Meningitis" workshop, while a (€5,000) grant awarded by The Ireland Funds, provided the resources required for a brand new support incentive this year "A Class ACT".



### **Community Fundraising**



Community fundraising has experienced a slight decrease overall in income this year in comparison to 2018. However, we have continued to establish new and grow existing relationships with many communities, businesses, committees and individuals across Ireland who have and will continue to fundraise and advocate on behalf of us, and as always, remain fully compliant with the Principals of Fundraising and continue to carry out best practice in all aspects of our fundraising.

# Support in 2019



Demand for Family Support remains quite high with many people discovering us through leaflets in their doctors surgery, we have had further home visits, crisis calls and a continued high uptake on family support from new and existing families.

In January 2019 we delivered the Don't Just Survive Thrive! workshop in Galway, this was well received with attendees reporting that techniques and tools taught have made significant differences since being brought into use.

We hosted our annual Remembrance Day in February in Wineport Lodge. This was the first

one that included child attendees, there was a mix of whole family activities and separate space for adults and children. All attendees reported positive benefits after the day.

We completed our You, Your thoughts, Your ACTions course in Galway, all participants enquired about possibly attending again as they found the additional benefits of having dedicated structured time supported them in enacting the learning, we are happy to provide this. Feedback from families suggested that running it in Galway once a year in the 2 day structure would allow others to attend who found weekly difficult to manage.

Our You, Your thoughts, your ACTions course ran in Dublin and was extremely well received with very positive feedback and requests for continued more frequent meet ups and support days.





At present we have a cohort of young adults who have experienced Meningitis and are experiencing after effects that don't fit in to our existing support services. We have spent time compiling feedback, reviewing need and developing additional support days to meet this need over the summer with a hope to beginning these early 2020.

We have had increased demand from families who would have previously been receiving a low level of support from us, changes in children's development and increased demands in school systems have brought emotional and sensory regulation difficulties to the forefront. We have played a role in advocating within the school system for the children's needs to be met.

Don't Just Survive, Thrive Day 2 ran in Galway all participants of Day 1 were in attendance again, we reviewed day 1 and progress before extending skills and practices.

We had our Summer Family Support Day on 18th August in Tayto Park. We had 4 new families join us for the family day who hadn't attended previously. The theme of the workshops was connection and strengthening family relationships. We received very positive feedback on the day.

Unfortunately our Christmas Family day didn't go ahead in December. Glendeer Pet farm cancelled their Irelands Lapland where we usually attend. Other locations available were

not viable for various accessibility reasons. We plan to offer an added family day next year to make up for this.

# **Financial Report**

### Income for 2019

2019 was a successful year for ACT for Meningitis, with an income of €152,199. This is due to an increase in support from corporate partnerships, grants trusts and community events as outlined in the fundraising section of this report.

### **Expenditure for 2019**

The expenditure for 2019 to date is €195,340, with a rapid growth in all areas of the organisation throughout the year expenditure has increased .Our national awareness campaigns across the country have grown from previous years, wide the addition of pharmacy countertop card holders nurse training and corporate events/talks. While other expenditure went towards the increase in our family support services with the introduction of new workshops across the country

### GENERAL INFORMATION

ACT FOR MENINGITIS COMPANY LIMITED BY GUARANTEE is a company limited by guarantee incorporated and registered in the Republic of Ireland. The registered number of the company is 505135. The registered office of the company is Unit 7, Royal Rock, Ballybane Industrial Estate, Gallway which is also the principal palace of business of the company. The principal activity of the company is a Charity to educate and create awareness of signs and symptoms of Meningtilis and fundrishing to finance these activities. The financial statements have been presented in Euro (€) which is also the functional currency of the company.

### SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Statement of compliance
The financial statements of the company for the year ended 31 December 2019 have been prepared in accordance with the provisions of FRS 102 Section 1A (Small Entities) and the Companies Act 2014.

Basis of preparation

The financial statements have been prepared on the going concern basis and in accordance with the historical cost convention except for certain properties and financial instruments that are measured at revalued amounts or fair values, as explained in the accounting policies below. Historical cost is generally based on the fair value of the consideration given in exchange for assets. The financial reporting framework that has been applied in their preparation is the Companies Act 2014 and FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" Section 1A, issued by the Financial Reporting Council.

The company qualifies as a small company as defined by section 280A of the Companies Act 2014 in respect of the financial year, and has applied the rules of the 'Small Companies Regime' in accordance with section 280C of the Companies Act 2014 and Section 1 A of FRS 102.

Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost or at valuation, less accumulated depreciation. The charge to depreciation is calculated to write off the original cost or valuation of tangible fixed assets, less their estimated residual value, over their expected useful lives as follows:

The carrying values of tangible fixed assets are reviewed annually for impairment in periods if events or changes in circumstances indicate the carrying value may not be recoverable.

Taxation

Current tax represents the amount expected to be paid or recovered in respect of taxable income for the financial year and is calculated using the tax rates and laws that have been enacted or substantially enacted at the Balance Sheet date.

Foreign currencies

Monetary assets and liabilities denominated in foreign currencies are translated at the rates of exchange ruling at the Balance Sheet date. Non-monetary items that are measured in terms of historical cost in a foreign currency are translated at the rates of exchange ruling at the date of the transaction. Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. The resulting exchange differences are dealt with in the Income and Expenditure Account.
